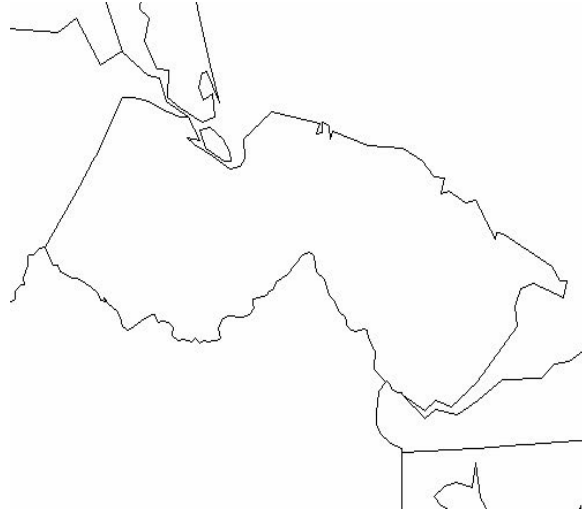

### ***Directions from the North:***

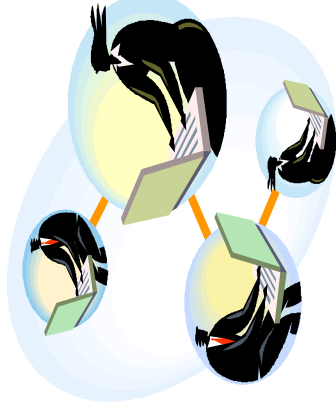
